

He was president of Perth Legacy (1959-60) and President of the Law Society of WA (1968-1970).

He has been Chairman of the Parole Board and Supervised Release Review Boards of

Western Australia. He was appointed AO in 1992.

Born in 1924 he married Dorothy Helga Johnson in 1949 and they have four children.

WELFARE OFFICER'S REPORT. HEALTH CONCESSIONS:-

If you are a veteran or war widow with a Repatriation card for all conditions (gold card) that card should always be used when accessing medical, hospital, dental, pharmaceutical and allied health services. The card entitles you to a wider range of health benefits than those listed below.

If you are veteran with a Repatriation Health card for specific conditions (white card) you should use this card to access the health services in respect of accepted disabilities. The card entitles you to a wider range of services than the concessions than those listed below in respect of accepted disabilities.

If you only hold a Pensioners' Concession card you should use it in conjunction with your Medicare card when accessing health services (as should white card holders in the case of non-accepted disabilities).

AMBULANCE FEE CONCESSIONS:-

Pensioner Concession card holders are eligible for a 50% rebate on the cost of ambulance transport. No concession is offered on the Ambulance Benefit Fund membership.

DENTAL TREATMENT:-

Subsidised dental treatment is available to most Pensioner Concession card holders under the State Dental Scheme. Treatment can be obtained through any Perth hospital clinic, Perth Dental Hospital or, in cases where there are no clinics, through dental practitioners who participate in the Country Dental Subsidy Scheme. You may be asked to provide a statement of pension income. This may be obtained from DVA ('phone (09) 366 - 8444.

WELFARE OFFICER'S REPORT

DOMICILIARY NURSING CARE BENEFIT:

The benefit provides financial support to carers of frail aged, or younger people with a disability, who have been assessed as requiring nursing home level of care. The benefit is tax free, not means tested and is indexed each January.

EYE CARE:-

Card holders are eligible for free examinations with optometrists who bulk bill Medicare. Free eye examinations are also provided through government eye care clinics at selected public hospitals.

CONTACT:- Your local optometrist or eye clinic.

HEARING AIDS:

Hearing aids are available through Australian Hearing Services. You will be asked to pay an annual fee (currently \$25-00) to cover maintenance, repairs and the supply of batteries. Those who own hearing aids are entitled to batteries at the same annual fee.

PATIENTS' ASSISTED TRAVEL SCHEME (PATS):-

The scheme provides financial help for travel and accommodation expenses to WA country residents who must travel more than 100 km one way to obtain essential specialist medical treatment which is not available locally or from a visiting specialist.

Financial help is provided for accommodation when the specialist specifies it is necessary for the patient to stay overnight for follow up treatment. Applications for assistance must be completed by a GP and lodged prior to departure at the nearest public hospital.

PHARMACEUTICALS:-

You are entitled to prescription medicines listed on the Pharmaceutical Benefits Scheme (PBS) at the concessions price of \$2.70 per prescribed medicine. You will pay more than the \$2.70 if the medicinal is not listed on the scheme or is only partially covered. There is a SAFETY NET. You should obtain a Prescription Record from a pharmacy or public hospital and ask your pharmacist to record your purchases of prescription medicines on it. When the total of your recorded spending exceeds \$140-40 in a calendar year you are entitled to most scheme medicines free of charge for the rest of the calendar year.

SPECTACLES SUBSIDY SCHEME:-

Under the scheme Pensioner Concession Card holders are entitled to claim a 50% subsidy on the cost of one set of spectacles every two years (to a maximum of S50=00). If you are entitled to assistance for spectacles from DVA you are not entitled to a further subsidy under this scheme.
